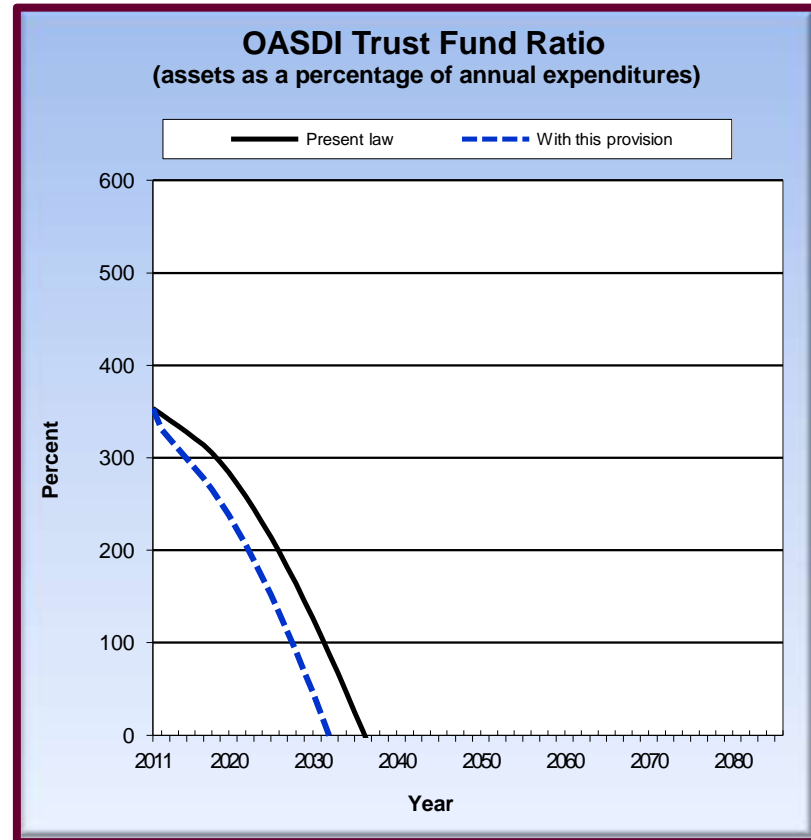
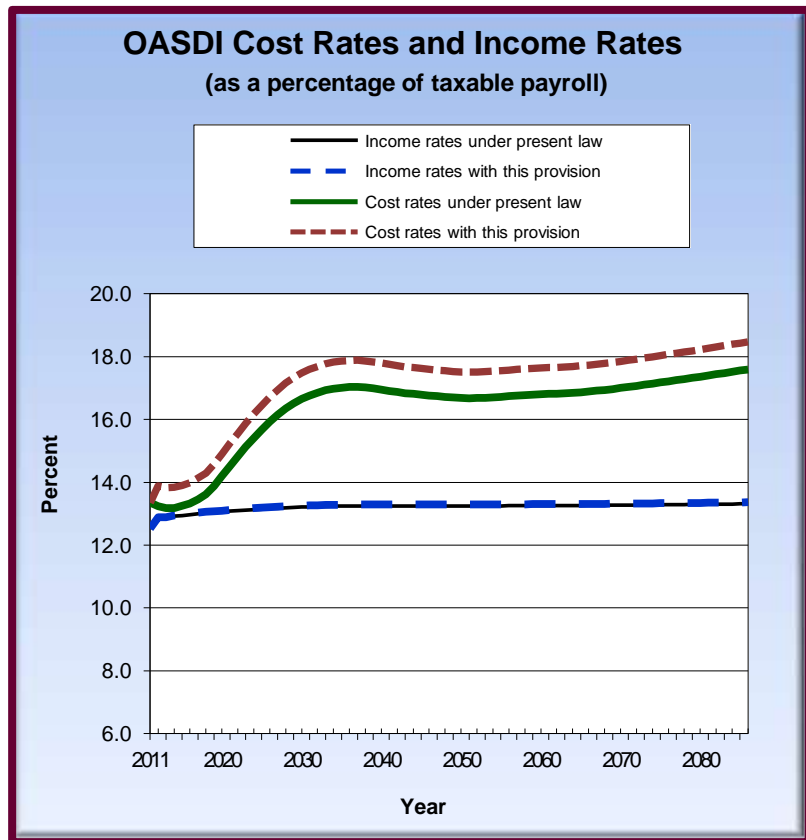


## Summary Measures and Graphs
